



# CAMPING DE LA PLAGE ★★★

## Interior Rules

### 1. TERMS OF ADMISSION

To be accepted to enter, install and stay on the campsite, you must have received the authorization of the manager or his representative.

Staying on CAMPING DE LA PLAGE implies agreeing to the terms of these internal rules and the commitment to comply with them.

Any violation could cause the removal of its author.

In case of criminal violation, the manager could ask the intervention of law enforcement officials.

Please note that the campsite is reserved to holidaymakers. As a consequence, customers can not take up residence on the site.

### 2. POLICE FORMALITIES

Any person staying for at least one night on the campsite, must present his identity papers to the site manager or his representative, leave his camping membership card and fill out the necessary formalities required by the police.

Minors will only be accepted when accompanied by their parents.

### 3. INSTALLATION

Tents, caravans, camper vans and mobile homes and their belonging equipment must be installed on the indicated pitch, in compliance with the instructions given by the manager or his representative, without exceeding 30% of the surface of the pitch.

Caravans and mobile homes must at all times keep their means of movableness.

### 4. RECEPTION DESK

Open from 8 am to 7 pm during the high season. Available at the reception: information about the services on site, information about grocery shopping, the sports equipments, the tourist sites in the region and various useful addresses.

Customers can leave their claims in a special box. They will be taken into account when legibly signed, dated, as detailed as possible and referring to relatively recent facts.

### 5. FEES

Fees must be paid at the CASH DESK during the opening hours, from 8 am to 6.30 pm during the high season. The amount of the fees is displayed at the campsite entrance and the reception desk. The fees must be paid following the number of nights spent on site.

One day before they leave, site users are invited to inform the reception desk of their departure, in order to pay the fees for their stay.

Campers intending to leave before the opening of the cash desk, must pay their fees on the day prior to departure.

## 6. NOISE AND SILENCE

Campsite users are immediately asked to avoid noise and discussions that could disturb their neighbours.

Dogs and other pets should never be left in liberty, nor left on the campsite, even locked-in, in the absence of their liable owners who must present an up-to-date vaccination booklet.

Complete silence must be respected between 10.30 pm and 7 am.

## 7. VISITORS

Visitors can be admitted on site, after approval by the manager or his representative. They must comply with the terms of these internal rules and pay the applicable visitor's tariff. Visitor's cars are not allowed on site.

Access to the campsite is strictly prohibited to door-to-door salesmen, hawkers and other street peddlers.

## 8. TRAFFIC AND PARKING

On site, vehicles can not exceed the speed limit of 10 Km/h.

On site, the only vehicles that can drive around are the ones belonging to the campers staying on site. They can only park on their own parking space. Parking must not hamper traffic or the installation of new arrivals.

## 9. CONDUCT AND ASPECT OF THE FACILITIES

Each customer is held to refrain from anything that could harm the cleanliness, the hygiene or the aspect of the campsite and its facilities, and in particular the sanitary facilities.

It is prohibited to throw away waste water on the ground or in the gutters.

Campers with caravans and camper vans must empty their waste water in the waste water facilities.

Household rubbish, waste of all nature and paper must be thrown in the bins, while respecting the waste sorting.

Washing clothes is strictly prohibited outside the washing sinks.

Hanging up the wash can be done near the camping equipment, until 10 am. After this time, it is tolerated when done in a discreet way, without disturbing any neighbours. Wash may not be hung up on lines between trees or bushes.

Plants and flowers must be respected. It is absolutely prohibited to gather or pick anything. It is prohibited to hammer nails or other instruments in the trees, cut branches or plant anything.

It is also not allowed to delimit the pitch by personal equipments, or to dig holes.

Any damage caused to the plants, the fences, the site or its installations will be invoiced to its author.

The occupied pitch must be kept in the same state as the camper found it upon arrival.

## 10. SECURITY

### 10.1 Fire

Barbecues and fires (wood, charcoal, etc ...) are COMPLETELY PROHIBITED.

Camping stoves must be kept in a good state of functioning and must not be used under dangerous circumstances.

Fire hydrants are EXCLUSIVELY RESERVED to be used in case of a fire.

Extinguishers are available to all customers. In case of a fire, please immediately inform the management.

A first aid kit is available at the reception desk.

### 10.2 Theft

The management is liable for items left at the reception desk and must watch over the campsite. The camper is liable for his own equipment and must inform the manager of the presence of any suspect persons.

Even though there is a security team, campers are invited to take their usual measures to protect their equipments.

## 11. GAMES

Violent or disturbing games near the facilities are prohibited.

Children must be under their parents' surveillance at all times.

## 12. STORAGE

Unoccupied material and camping equipment can only be left on site after approval by the management and on the indicated pitch only. The management is not liable for this material in the absence of its owner. The fee indicated at the reception desk must be paid for this type of storage of camping equipment.

## 13. DISPLAY

These interior rules are displayed at the entrance of the campsite as well as at the reception desk. They will be handed to the customer upon request.

## 14. VIOLATION TO THE INTERIOR RULES

In case a resident would disturb other holidaymakers or not comply with the terms of these interior rules, the manager or his representative could, if he decides it would be necessary, give verbal or written notice to the latter to stop disturbing other holidaymakers.

In case of severe or repeated violation of the interior rules and after formal notice by the manager to comply with them, the manager could terminate the contract.

In case of criminal violation, the manager could ask the intervention of law enforcement officials.

### SPECIFIC TERMS

A night on the campsite is counted from 2 pm to 2 pm, but ends at 12 am on the day of departure. To help new occupants to install their equipment, pitches must be vacated at 12 am on the day of departure. Any started day is due.

The count of the nights starts upon arrival on the campsite (when the arrival takes place during the night, that day must be paid), and it stops on the time of departure. Therefore, the pitch must be vacated at 12 am at the latest on the day of departure; otherwise a new night will be due.

A toleration of half an hour during the high season and one hour during the low season can be given if the pitch is not reserved on that particular day.

Holiday fees must be paid on the morning of departure or the day prior to departure, depending on the opening hours of the cash desk and the time of departure. Down payments could be asked upon arrival and during the stay. The customer also has the possibility to pay part of his stay at any time.

The disconnecting of the electric equipment can only be done during the opening hours of the reception and will only be done by the authorized staff, after being informed early enough.
